

FEDGROUP PORTAL GENERAL TERMS AND CONDITIONS

1. INTRODUCTION

- 1.1 These terms and conditions govern your use of the Fedgroup Financial Services 2010 (Pty) Limited's ("Fedgroup" or "us" or "we") portal situated at <u>www.fedgroup.co.za</u> ("Fedgroup's portal" or "this portal"). Please read the portal terms and conditions in full before you use this portal.
